Spring Enrollment is Up

The University of Louisiana System remains the state's largest higher education system in terms of enrollment with approximately 74,000 students in classes this spring. Combined, the eight universities had an overall growth of 2.34 percent over last spring.

The 1,500 increase in students does not reflect the spring enrollment of Louisiana Tech University, which is on a quarter system. Their enrollment number will not be finalized until next month.

Nicholls and Southeastern Increase Admissions Standards for Fall 2010

The Board of Supervisors for the University of Louisiana today approved requests by Nicholls State University and Southeastern Louisiana University to implement higher admissions standards starting Fall 2010. This is a full year ahead of the Fall 2011 deadline approved by the Board for all eight universities in October 2009.

"We applaud and support Nicholls and Southeastern for moving aggressively in raising standards. It is a key indicator in improving academic success of students," said UL System President Randy Moffett.

Both universities conducted considerable analysis on impacts to enrollment and projec-

tions on how successful students would be under these new standards.

“This move to enhance admission standards clearly reflects the increasing quality of our student applicants. Nicholls is a strong academic institution as reflected in this change,” said Nicholls President Stephen Hulbert.

Southeastern’s new standards go slightly beyond minimum standards set by the board.

“With this increased importance being placed on graduation rates, we intend to sharpen our focus on recruiting students who possess the academic preparation to succeed in a university environment,” said Southeastern President John Crain.

120-Hour Degree Standard to be Implemented

University of Louisiana System Provosts will be hard at work paring down the number of hours required to earn a four-year degree at our eight universities. This week, the Council of Vice Presidents of Academic Affairs endorsed a move to initiate a system-wide 120-hours degree requirement standard.

Currently, there are over 451 four-year degree programs across the eight universities, 39 of which

meet this 120-hour standard. The remaining 412 programs will be pared down. Exceptions will be given to programs that for accreditation reasons, require additional hours beyond this standard.

“This move will decrease time to graduation and decrease costs, while not sacrificing quality,” said UL System Provost Brad O’Hara.

Provosts will begin their work immediately on the campuses.

FACILITIES PLANNING

- Grambling: name the Assembly Center the “Fredrick C. Hobdy Assembly Center.”
- McNeese: enter into a Local Services Agreement with the SWLA Alliance Foundation, Inc., Calcasieu Parish Police Jury, and the City of Lake Charles involving the development, construction, and operation of the Southwest Louisiana Entrepreneurial and Economic Development (SEED) Center.
- Northwestern: enter into a general agriculture lease for three tracts of land in Desoto Parish totaling 366.98 acres.

- Northwestern: authorize the State Mineral Board to offer for lease two tracts of land in Desoto Parish totaling 110.17 acres
- Northwestern: enter into a Lease Agreement with Northwestern State University Foundation, Inc. to construct a pavilion in an area adjacent to Turpin Stadium and donate the improvements to the University.
- UL Lafayette: demolish two buildings located on the main campus to allow for the construction of a new Softball Stadium.
- UL Lafayette: demolish four buildings located on the main campus to allow for the planned renovation and expansion of the Student Union Complex.

FINANCE

- Nicholls: student referendum to fund operations of the Recreation Center and Activities Program.
- Nicholls: provide an advanced business program via a contractual arrangement with individuals and/or organizations to be named the Executive Master of Business Administration Program.
- UL System: establish LEQSF (8g) Endowed Professorships/Scholarships. (see margins for details)
- UL System: 2010-11 undergraduate and graduate mandatory attendance fees.
